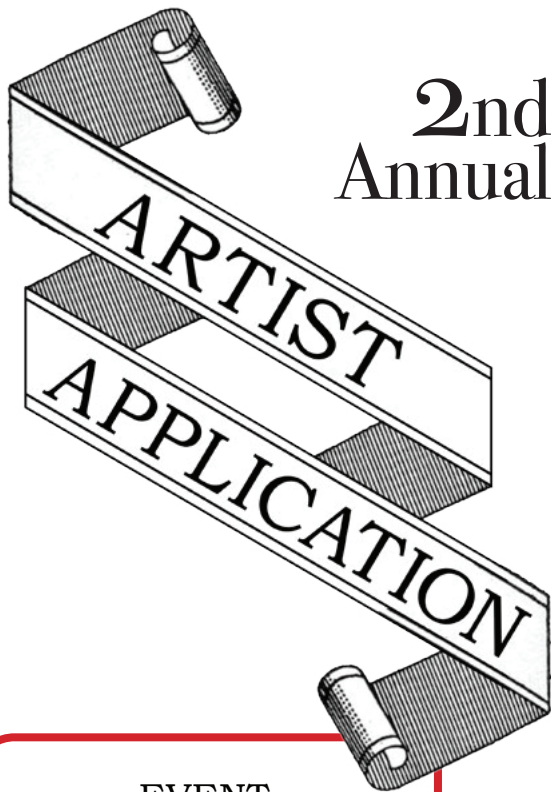
Additional information and details are provided in the application packet available now under the events section of the Borough's website. The deadline to apply is August 15th! Space is limited so please apply early!

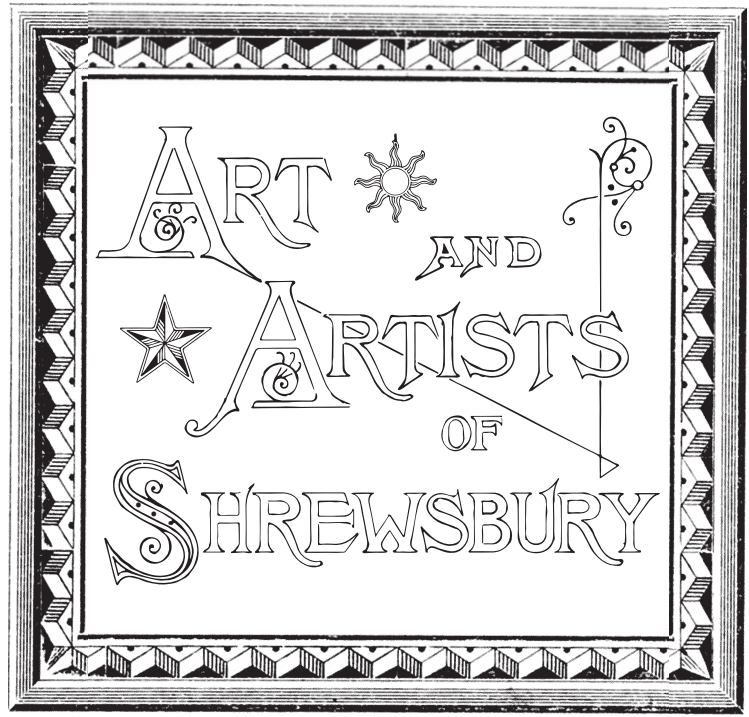

RULES AND REGULATIONS:

All Artists must be residents of Shrewsbury.

All Artists must be 18 years of age or older.

All artists must display only original pieces as described in this application.

Artists may opt to just display their work, "Show and Tell".

If they choose, they may also sell their work following NJ tax laws with their Tax ID certificate visible or by use of Squarespace tax collection platform.

Artists must supply their own displays (tables will be provided if necessary per Application).

No canopies nor tents permitted. Artists are responsible for setting up and tearing down booths.

A professional looking table/booth is a must.

Each exhibiting section will be approx. 12' w x 8' d with display not extending beyond the space or disrupting traffic flow.

Participants will need to unload vehicles at curb and then move cars to designated parking (gopher field). Cars may not be left in the loading zone while setting up areas.

Bring a hand cart or dolly if needed.

Participants may arrive between 9am-10am and must stay thru until 3pm. Setup must be complete by the start of the event at 11am. Tear down will begin at 3pm with no early tear down.

Artists are fully responsible for the care, safety and security of their own property.

Shrewsbury Borough, employees and event coordinators assume no responsibility for any loss or damage to any inventory, artistic works, display materials, or artist's personal property for any cause whatsoever.

Artists are responsible for cleaning up their booth area, leaving no trash nor debris behind.

Generators are not permitted, and there will be no electric or water available.

All Artists must sign and submit the "Hold Harmless Agreement" and the "Rules & Regulations" pages along with their completed Application.

Applications must be received by August 15th.

The Borough and event coordinators reserve the right to refuse applications for any reason that they deem does not properly serve this event.

All applications will be taken on a 1st come 1st serve basis with discretion by event coordinators to ensure a variety of mediums within the limited space.

All applicants will be notified via email if accepted/confirmed for the event on August 20th.

The \$5 Participation Fee for Confirmed Artists must be delivered in person to the Rec Coordinator at Boro Hall from Wed. August 20th to the deadline of Sept. 12th.

HOLD HARMLESS AGREEMENT

Assumption of Risk Waiver and Release

In consideration of being allowed to participate in this Borough sponsored activity, Artists in the Park, I hereby assume all risks of injury, damage, liability and harm to myself my property, and any individual or minor child that I may bring to Borough property for purposes of participating, setting up or attending the Artists in the Park Event. In addition, I am aware that I am fully responsible for the actions of anyone for whom I provide access to my particular art exhibit or neighboring art exhibits. By signing this agreement, I am acknowledging and agreeing that I shall be responsible for any injuries or damage caused by such persons and will hold the Borough harmless for myself or any of my visitors or surrogates. For avoidance of doubt, by signing this agreement I am acknowledging and agreeing that I am participating in the Artist in the Park Event at my own risk.

The undersigned shall defend, indemnify, and hold harmless the Borough, its officers, agents and employees, from and against any costs, including but not limited to reasonable attorneys' fees and costs of suit, arising out of or resulting from the use of municipal property or facilities by the undersigned, regardless of whether such liability arises in tort, contract, strict liability, or otherwise, to the fullest extent allowed by law, provided that any claims, damages, loss, or expenses are (i) attributable to bodily injury, or to injury to or destruction of tangible property and (ii) are caused by any negligent or willful act or omission by the undersigned or the undersigned's agents, invitees or guests. In the event the injury or property damage is caused in part by the negligent or willful act or omission of the undersigned, the undersigned shall only be required to defend, indemnify and hold harmless the Borough of Shrewsbury, its officers, agents and employees to the extent of undersigned's negligence or willful act or omission. These Hold Harmless and Indemnification Clauses shall apply without contribution from the Borough's insurance carriers.

I also hereby individually and on behalf of my heirs, executor, and assigns, release and hold harmless the Borough of Shrewsbury, borough officials, employees, agents, volunteers and members, and waive any right of recovery I might have to bring lawsuit against them for any personal injury, death, or other consequences that may occur as a result of the use of municipal facilities by me or any of my guests.
