Administrator's Report

Mr. Seaman reported for the Tax Assessor, Bill FitzPatrick, on the settlement of the tax appeal for the previously owned Stop and Shop. Attorney Barger noted that he was not able to relay specifics but acknowledged that this was a good settlement for the Borough. He noted that Mr. FitzPatrick is working on resolving two others, one which may possibly be withdrawn, which would leave only one left to be tried which was Treasure Island. Mr. Barger noted this particular appeal will be a difficult one to settle. Mr. Barger reported that there were a number of prior tax appeals that Mr. FitzPatrick inherited from the previous assessor and that Mr. FitzPatrick has done a very good job bringing to closure the prior outstanding appeals.

Mr. Seaman stated that the deadline for articles for the Borough Newsletter is December 11. He reported on the status of the search for the pending open Clerk position and noted receiving 10 resumes that he and Clerk Krueger would be reviewing and setting up interviews for the potential candidates. Mr. Seaman noted that he and Ms. Grieco are working on the Borough Directory and requested any suggested changes be made as soon as possible. Mr. Seaman shared with the Mayor and Council that he had learned of the passing of retired Officer Sojka who passed away the previous week. He stated that he had worked for the Borough for over 25 years.

Reports of Council

<u>Councilman Anderson</u> reported that the Shrewsbury Board of Education election is scheduled for tomorrow with 7 candidates running for 3 spots. He stated that he had forwarded the Fire Department October activity log to the Council. He also reminded the public about the Comedy Night fundraiser the Shrewsbury Hose Company is sponsoring on Saturday night.

Councilwoman DerAsadourian stated she had nothing to report this evening.

<u>Councilman DeSalvo</u> reported on the Community Alliance program 'Under the Influence' covering prescription drug abuse was being held at the high school tonight. He noted the importance of this topic.

<u>Councilman Eddy</u> reported that the budgets need to be in before Thanksgiving so initial meetings with Mr. Seaman could be in early December. He reminded everyone to include Capital Improvement plans with their 5 year view as well as their budget needs for the next year. Mr. Eddy noted they would be looking to meet with each of the groups in December.

Councilman Meyer stated he had nothing to report this evening.

<u>Councilman Moran</u> reported that leaf collection was in full swing with both the loaders and new Packer truck being utilized. Mr. Moran noted that brush collection ceases on 10/31 and he noted the Code Red message that was issued advising residents not to put brush out after that date. Mr. Moran noted that one of the contractors's loaned the Borough their roller equipment to address the swale on the western side of the walking trail which was tested with the recent rainfall and held up really well. He noted the new machine is working well on the ball fields. Councilman Moran noted that DPW met with Oceanport and Fort Monmouth concerning the maintenance of the Jet Truck and the Street Sweeper and has planned training on this equipment for later this week. He noted the Ave at the Common project is entering its final stages. Councilman Moran read into the record the letter from Mr. Dan Becker which praised DPW for their maintenance of the Borough on a daily basis. Mr. Becker praised the excellence of their work and stated that they are rarely acknowledged for helping Shrewsbury remain the treasure that it is.

Mayor's Report – The Mayor listed the numerous events he attended which included meetings for the Tree/Menorah Lighting, State OEM, Homesteaders, Monmouth County Archives Day, Shared Service meeting with Mayor Neff, Planning Board, SBS updates meeting with Brent MacConnell, Monmouth County Historic Commission and the Two River Council of Mayors. In addition, he was present for the Shrewsbury 5K Race, participated in the Monmouth County Library presentation to Freehold Director Lillian Burry, the Fall Festival at the Grove, Shrewsbury Green Team presentation at SBS, Shrewsbury Historical Autumn Harvest celebration and Holmdel library ribbon cutting event in the Old Bell Labs building. He noted that he also participated in the active shooter training at the Shrewsbury Surgical Center along with our Police Department, OEM, Fire and First Aid. The Mayor acknowledged the new lights installed on Patriot Isle which was gifted by Broadway Lighting in honor of the continued dedication and work done by Ron Neis for Shrewsbury Borough. Mayor Burden also acknowledged Karen Lloyd for championing safety in the Borough. He read a statement from the report of the MEL-JIF which stated "Survey reveals no significant deficiencies and there is an indication of good safety management practices throughout the Borough. No new suggestions of improvement are being submitted." He thanked Karen Lloyd again for all her hard work.
