**Ordinance No. 2018-1055**: An Ordinance Amending the Chapter 94, Land Use and Development, of the Code of the Borough of Shrewsbury, County of Monmouth and State of New Jersey by Supplementing Chapter 94 to Include Mandatory Set-Aside Language to Facilitate the Provision of Affordable Housing in the Borough

Mayor Burden noted for the record that the following additional language was added to section G.1: *"any of which has been adopted or issued subsequent to the effective date of this ordinance."* 

This is just a language addition not a content addition.

Tom Menapace, 74 Robinson Place – Mr. Menapce asked if the assisted living facilities are under any mandate to provide affordable housing for low income seniors. Councilman Anderson replied yes, eleven for each assisted living facility. We received twenty two credits between the two assisted living facilities in town.

Janet Dill, 115 White Street – Mrs. Dill ask what qualifies as affordable, what is the definition. Marty Barger explained it is set by statute as to the income levels. Varies from time to time.

- Mr. Seaman commented that he and Jerzy Chojnacki finalized the OEM Grant that was for \$10,000.
- Together with the Police Department Mr. Seaman filed for the Drunk Driving Enforcement Grant which will be approximately \$6,488.
- Mr. Seaman also filed for Body Armor Grant which generally allows us to purchase two vests.
- \$20,000 was received from JIF for our yearly dividend.

- Councilman Anderson reported that the heater in the DPW bay where the diesel equipment is kept stopped working. The cost to replace is \$6,600. The DPW Committee recommends replacing it – it is needed particularly with the men working in there.

- Councilman DeSalvo and Councilman Eddy have been busy this week with a malicious email attack. Luckily the firewalls that were put in place last year stopped it. It did not affect the Borough's network.

- Councilman Eddy explained that new security measures will need to be implemented in order to stop malicious emails from coming in which means changing email servers.

Marjorie Clark, 213 Garden Road – Mrs. Clark asked if Shrewsbury have guidelines on how a building is to look in our town - can the town keep a certain image. Councilman Anderson replied there are some guidelines under the Municipal Land Use Law. Mrs. Clark thanked Mayor Donald Burden for all his hard work and dedication to the Borough.

Thomas Menapace, 74 Robinson Place – Mr. Menapace asked if the town is still doing singlestream recycling. Councilman Anderson responded yes, at least for the term of the contract.
