### **Administrator's Report**

- Mr. Seaman reported he attended a NJ FRAMES Steering Committee Meeting (NJ Fostering Regional Adaptation through Municipal Economic Scenarios) last week which deals with coastal hazards and storm surges. It deals with fifteen different municipalities and there was a grant set up last year by the State. Mr. Seaman added that the steering committee will vote on a plan and he will ensure Shrewsbury's concerns are noted.
- Mr. Seaman added he will be attending an Emergency Grant Workshop next week in Kearny and he will also attend a MEL JIF Supervisor Management Training Seminar next week in Little Silver.

# **Reports of Council**

### Councilman Anderson

- In regards to North Monroe and Monroe, Mr. Anderson reported we are still waiting for a response from the State when to invoke the plan, but he has not received a response as of date.
- There will be a scope of work meeting for Obre in the next two weeks.
- Mr. Anderson commented that we are going to need to figure out what to do with the extra generator which is here at the municipal building. He further commented that we need to power DPW and we are looking into the possibility of a less expensive alternative to operate DPW energy through the new generator.
- Shrewsbury Board of Education has a meeting tomorrow. The preliminary budget came out indicating that aid would be increased to Shrewsbury by 13% \$253,000 to \$286,000. Mr. Anderson commented that this is still inadequate for the proper funding of our school. Mr. Anderson met with the Policy Director for local district 11 elected officials to discuss the underfunding of Shrewsbury's school district and the impact on our property taxes. Mr. Anderson also spoke to the Policy Director regarding special education needs for the Board of Education and also brought up the inequity in the manner of the tax of RBR and that we are taxed at a higher rate than Little Silver and Red Bank.

- Regarding COAH, Surenian Office submitted a proposed form of order to Judge Perry on Friday to effectuate the settlement agreement that the Council voted on a number of months ago.

#### Councilwoman DerAsadourian

- Ms. DerAsadourian reported that the Personnel Committee is continuing to review the Personnel Manual to make sure policies are current and that the Borough stays up to date.
- She also attended a meeting with the fire company to discuss their upcoming needs.
- Ms. DerAsadourian noted that the fire company is looking to refurbish one of the pumper
- There will be an Open Space Meeting to discuss some of the things that need to go on with the parks this coming year and in general some upgrades. When there is a proposal it will be presented to the Council.

### Councilman Eddy

- Mr. Eddy commented tonight was the Introduction of the 2018 Municipal Budget and the public hearing/adoption will be on the April 16<sup>th</sup> agenda.
- In regards to insurance and benefits, Mr. Eddy commented there are discussions to what the program currently looks like and what are some possible changes as we head towards negotiations this year.
- Mr. Eddy spoke with Sea Bright and they are interested in participating in sharing services. Moving forward we will need to schedule a meeting with them and Oceanport.
