Thank you for your service not only to the residents of Shrewsbury, but throughout our County.

I want to start by congratulating Deidre, Brendan and Jason on being re-elected. Your margin of victory in November is a testament to the great results you are achieving for Shrewsbury. The Borough is better because of your service on the Council. Again, thank you for all you do for our town.

I would also like to recognize and congratulate our new incoming Council President – Kim. The Council and the Borough will be well served by your leadership. I look forward to working with you in the coming year.

In looking back at 2019, I am extremely proud of what the Council has accomplished. Last year I asked that the Council undertake an examination of the Borough's operations to ensure that we are delivering the most cost-effective services for our residents. I am pleased to report that through various changes within our operations, the Council has been able to continue our great level of Borough wide services while reducing Shrewsbury's municipal spending for the first time in a decade.
