RESOLUTION TO ENTER INTO A SHARED SERVICES AGREEMENT FOR THE POSITION OF CHIEF FINANCIAL OFFICER AND TAX COLLECTOR WITH THE TOWNSHIP OF HOWELL

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 *et seq.* (the "Act"), including N.J.S.A. 40A:65-4.1 to -7, authorizes local units of this State to enter into agreements with any other local unit or units to provide or receive any shared service that each local unit participating in the agreement is empowered to provide or receive in its own jurisdiction; and

WHEREAS, Shrewsbury has identified an area where working together with the Township of Howell through shared services will result in a benefit to the Borough; and

WHEREAS, N.J.S.A. 40A:9-140.10 requires each municipality to have a Chief Financial Officer but same may be provided by an agreement with another municipality; and

WHEREAS, Shrewsbury desires to contract with Howell for the furnishing of services of Chief Financial Officer and Tax Collector; and

WHEREAS, Howell has agreed to furnish to Shrewsbury the services of its Chief Financial Officer and Tax Collector pursuant to N.J.S.A. 40A:65-1 et seq.;

WHEREAS, in the spirit of inter-municipal cooperation, and in furtherance of the principles underlying the Act, Howell and Shrewsbury (collectively "the Parties") have negotiated an Agreement for the provision of the Chief Financial Officer and Tax Collector services for their respective jurisdictions; and

WHEREAS, Shrewsbury has complied with the procedural requirements for shared services agreements between pilot municipalities, pursuant to N.J.S.A. 40A:65-1 et seq., including the holding of a public hearing regarding such shared services agreement.

NOW THEREFORE, BE IT RESOLVED by the governing body of the Borough of Shrewsbury that the Borough's participation in the shared services agreement with the Township of Howell for Chief Financial Officer and Tax Collector, a copy of which is attached, is approved; and

BE IT FURTHER RESOLVED that the Mayor and Clerk are authorized and directed to execute the shared services agreement in substantially the form attached hereto and incorporated herein by reference; and

RESOLUTION APPLYING FOR THE LOCAL EFFICIENCY ACHIEVEMENT PROGRAM OR "LEAP" IMPLEMENTATION GRANT

WHEREAS, the State of New Jersey has appropriated \$7.5 million for Shared Services and School District Consolidation Study and Implementation Grants to assist local units with the study, development, and implementation of new shared and regional services; and
