Discussion and Action

Shrewsbury Centennial Committee- Mayor Anderson

Mayor Anderson stated that we will be celebrating the centennial in 2026 and to form a committee, of Councilman Sena, Former Mayor Donald Burden and Recreation and Community Events Coordinator Victoria Caufield. If this is approved to be formed than the members will be able to get the “ball rolling” on this event. There were no objection from Council to begin this process.

Dispatch- Mayor Anderson

Mayor Anderson explained that the “board” in Dispatch has surpasses its life expectancy, and it is no longer a viable option to continue to have dispatch in house. There has also been an issue regarding the radios that police and dispatch use to communicate with each other and other departments. There have explored multiple opportunities to have

dispatch work, doing a shared service with Little Silver to which none have come to fruition. In addition, to this dilemma that the Borough is facing, there is also a staffing issue.

Mayor Anderson went on to explain that Council has looked into purchasing a new system which would cost from 1 million to 1.3 million dollars, and then we will still need to staff it, which is the current issue. Over the course of the previous roughly eight (8) years that dispatch has been a topic of conversation, Mayor Anderson explained that the concerns that have been brought up have been resolved, whether it be the cameras that dispatch currently has to monitor the school, which now there is a SLEO in the school. In the event another Superstorm Sandy happens, there is now that option to have a remote center located within the borough.

Mayor Anderson closed the dispatch discussion, stating that there will be bumps in the road as there is with any change. However, he along with Council believe that this is the most advantageous decision.

-SRTS is working with the Borough Engineer on traffic calming strategies for Sycamore Avenue and RT. 35

Councilman Eddy:

-Brush pickup is currently underway.

Councilman Gilmartin:

Dear Mayor Anderson and fellow members of the Shrewsbury Borough Council,

I regret that a personal conflict led to my absence from tonight's meeting but nevertheless wanted to submit for the record my support for the Shared Service Agreement (Resolution 2023-073) with the County of Monmouth for Emergency Dispatch Services.

As Councilman my highest priority is the safety and welfare of Shrewsbury residents. Part of that commitment includes emergency response services and ensuring necessary help arrives expeditiously.

During the past several years, Shrewsbury's dispatch professionals performed valiantly and professionally in their duty to provide enhanced public safety. However, there are impediments impacting our dispatch capabilities which have proven difficult to overcome, including staffing shortages, scheduling conflicts, and aging equipment which is exceedingly difficult to maintain and less compatible with other systems rendering communications with responders in nearby towns increasingly challenging.

In an effort to maintain centralized, local dispatch services, I and other council members have met with neighboring towns to discuss pooling resources to share this vital service. For various reasons, those overtures were unsuccessful. Careful assessment into the technology upgrades was also conducted but proved futile when balanced with the prospect of persistent staffing shortages.

Therefore, after close consultation with emergency responders across Shrewsbury's police, first aid, and fire departments, careful study of the County of Monmouth's dispatch services, and resident safety, I am supporting Resolution 2023-073 and the appropriation of the funds requested under Ordinance 2023-1107.


Close the Floor to the Public
