WHEREAS, on October 17, 2022 the Mayor and Council of the Borough of Shrewsbury adopted Resolution No. 2022-126 authorizing the execution of a Shared Services Agreement with the Shrewsbury Board of Education for the hiring of a Class III Special Law Enforcement Officer; and,

WHEREAS, pursuant to that Shared Services Agreement, it is mutually agreed between the Borough and the Shrewsbury Board of Education that one (1) Class III Special Law Enforcement Officer be hired to assist in providing adequate security to the Shrewsbury public schools; and,

WHEREAS, pursuant to N.J.S.A. 40A:14-146.10(e), the Borough Police Chief reviewed applications and confirmed the eligibility and qualifications of Michael Lahey, and recommends Michael Lahey to serve in the position of Class III Special Law Enforcement Officer; and,

WHEREAS, the Governing Body agrees with the recommendation of the Borough Police Chief and, pursuant to the terms of the aforementioned Shared Services Agreement with the Shrewsbury Board of Education, desires to hire Michael Lahey to serve in the position of Class III Special Law Enforcement Officer.
