AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF SHREWSBURY IN THE COUNTY OF MONMOUTH AMENDING AND SUPPLEMENTING CHAPTER 5, ARTICLE X, DEPARTMENT OF PUBLIC WORKS, OF THE SHREWSBURY BOROUGH CODE

WHEREAS, the Borough previously adopted Chapter 5, Article X, Department of Public Works, in the Borough Code establishing the Department and the position of Public Works Manager and codifying the powers and duties associated with that position; and,

WHEREAS, the Borough desires to amend the existing Borough Ordinance to amend the title and qualifications associated with the position of the Public Works Manager; and

WHEREAS, all additions are shown in **bold italics with underlines**. The deletions are shown as **strikeovers in bold italics**. Sections of Chapter 5, Article X, Department of Public Works, that will remain unchanged are shown in normal type.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Borough of Shrewsbury, in the County of Monmouth, in the State of New Jersey, as follows:

March 12th, 2024

SECTION ONE. The Code of the Borough of Shrewsbury shall be amended as follows:

§ 5-44 Establishment of Department.

There is hereby established a Department of Public Works, the head of which shall be known as the "Public Works *Manager Director*."

§ 5-45 Term and qualifications of Public Works Manager Director

The Public Works *Manager Director* shall be appointed by the Mayor with the advice and consent of the Council. He shall hold office at the pleasure of the Council and shall attain tenure of office after five years of continuous service as provided by law. He shall be certified pursuant to N.J.S.A. 40A:9-154.6a et seq., within two (2) years of the effective date of his/her appointment. If the Borough pays for or reimburses the Public Works Director for necessary classes to be certified pursuant to N.J.S.A. 40A:9-154.6a et seq., the Public Works Director shall be required to serve in the roll of Public Works Director for a period of two (2) years following the receipt of said certification. If the Public Works Director elects to not serve for two (2) years after receipt of his certification, the Public Works Director shall reimburse the Borough for all costs and expenses associated with necessary classes to be certified pursuant to N.J.S.A. 40A:9-154.6a et seq.

§ 5-46 Powers and duties of Public Works Manager Director.

The Public Works *Manager Director* shall:

- A. Have general supervision over all matters relating to the construction, management, maintenance and operation of the physical properties of the Borough.
- B. Develop a comprehensive program for the removal of snow and direct the removal of snow and the cleaning of streets.
- C. Supervise and direct all maintenance and repair employees employed by the Borough.
- D. Be responsible for the servicing of all requests and complaints from citizens involving Borough facilities, including, but not limited to, storm flooding and road damages.
- E. Provide all mechanical services required by any department, office or agency of the Borough.
- F. Under the supervision of the Mayor and Council, <u>Administrator</u>, and/or the Borough Engineer, supervise the construction, reconstruction, maintenance and repair of all public streets within the limits of the Borough, and regulate street openings, the construction, alteration and repair of sidewalks, curbs and gutters, and encroachments by objects and structures above and below public streets and sidewalks, and prevent interference with the public use thereof, and maintain reasonable standards of maintenance and repair.
- G. Provide for the construction, reconstruction, maintenance and repair of storm sewer systems within the limits of the Borough.
- H. Operate and maintain all Borough properties.
- Perform such other duties as may be required by the <u>Administrator or</u> Mayor and Council.
- J. Supervise the collection and disposal of solid waste.
- K. The Public Works Director shall report to the Borough Administrator.

§ 5-47 Employees of Department; compensation.

The Public Works *Manager Director* shall <u>recommend for</u> hire such employees as are required for the performance of the duties set forth in this article, with the approval of

the Public Works Committee and the Personnel Committee, at a compensation to be fixed by the Mayor and Council by ordinance.

<u>SECTION II. REPEALER.</u> All Ordinances or parts of Ordinances inconsistent herewith are repealed to the extent of such inconsistency. The Borough Clerk is authorized to renumber and/or re-codify any sections affected by such repeal to the extent consistent with this Ordinance.

SECTION III. SEVERABILITY. If any word, phrase, clause, section or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal or unconstitutional such word, phrase, clause, section or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

SECTION IV. EFFECTIVE DATE. This Ordinance shall take effect upon publication thereof after final passage according to law and approval by the State of New Jersey.

Councilman Eddy along with Mayor and Council have implemented rules and regulations regarding the Electronic Sign Board at the Shrewsbury Borough Hose Company #1

All requests for information to be displayed on the Borough Sign at Shrewsbury Hose Company #1 will go through the Borough Administrator. No person other than the Administrator or their designated backup will have the ability to alter what gets displayed on the sign. Any exceptions or changes to these rules and guidelines must be approved by Council. For any questions or escalations, the Administrator or authorized backup may reach out to both the Mayor and Council President on guidance for messaging that does not fit within these rules or for emergency approval that can't wait until the next Council Meeting.

General Rules for Sign Usage:

- 1. Up to 5 Informational Messages defined as "Slides" will be programmed for display at one time.
- 2. The sign will statically display each message for no shorter in duration than 20 seconds.
- 3. There will be no animation/scrolling or flashing of any of the messages.
- 4. In the evening, the brightness of the sign will be reduced at sundown to 60%

General Guidelines for Sign Usage:

- 1. Messaging should be limited to Borough Topics, Departments, or Events including Standing and Ad-Hoc Committees established by Council.
- 2. Signage information should apply to most if not all residents and not just a small section of our residents.
- 3. Messaging can support Shrewsbury Hose Company #1
- 4. Messaging can support Shrewsbury First Aid
- 5. Messaging can support Shrewsbury Recreation Committee
- 6. Messaging can support the Shrewsbury Homesteaders
- 7. Messaging can support the Shrewsbury Historical Society
- 8. Information shall fit on one (1) "Sign"
- 9. Information shall not be considered trivial (e.g., Happy Birthday) without approval of the Council.
- 10. It is suggested that at least one "Sign" be always displayed if there are not more. This should be something that benefits the Borough such as, but not limited to 1st Aid and SHC are looking for members as an example.
