RESOLUTION AWARDING CONTRACT FOR THE 2024 ROADWAY IMPROVEMENT PROGRAM, BOROUGH OF SHREWSBURY, MONMOUTH COUNTY, NEW JERSEY

WHEREAS, the Borough of Shrewsbury advertised for bids for Roadway Improvements certain parking lot and roadway improvements to the Municipal Complex, Glorney Street, Allen Street, and Patterson Court as well as various other locations in the Borough of Shrewsbury, including; roadway base repair, HMA milling, curb construction, HMA resurfacing, construction of drainage improvements, turf restoration and incidental improvements; and

WHEREAS, the Governing Body of the Borough of Shrewsbury, acting on the advice of the Borough Engineer and Borough Attorney, does hereby make a finding that the bid submitted by L&L Paving Company does hereby best serve the interest of the municipality; and

NOW, THEREFORE, BE IT RESOLVED that the Governing Body of the Borough of Shrewsbury does hereby concur with the withdrawal of the bid submitted by Meco, Inc. and award a construction contract known as 2024 Roadway Improvement Program, to L&L Paving Company, Howell, New Jersey, in the amount of \$695,494.30; and

BE IT FURTHER RESOLVED that the presiding officer of this body be and is hereby directed to sign for on its behalf the contract in the prescribed form for said procurement and that the Clerk of this body be and is hereby directed to sign and seal said contract with the corporate seal of this body and attest to same.
